### Part 3: Important Information and Selection Process

The criteria for selecting students into the **Colorado River Collegiate Academy** are as follows:

- The applicant must reside in the Bastrop Independent School District.
- The applicant must meet ALL requirements for promotion from eighth grade to ninth grade.
- The applicant must complete the four admission essays as a part of this application.
- The applicant must go through an interview process with the staff of the Colorado River Collegiate Academy.
- The applicant must attend a two-week Summer Bridge Program in June of 2019.
- The applicant must have submitted the application for admission to his/her middle school counselor or CRCA principal by the deadline of January 9, 2019, for **Early Decision** or March 29, 2019, for **Regular Decision**. (Applications received after the deadline will be accepted, but will be placed on a waiting list).
- **Early Decision** candidates are given priority status.
- The applicant understands that competitive sports and fine arts are not offered at CRCA.

The selection process includes:

- Completion of the application and essays.
- Interview
- A lottery process will be used if more than 70 qualified students apply.
- A total of 70 students will be admitted into the CRCA Class of 2023.
