2. Superintendent's Report and Board Discussion

A. Curriculum Report

1. 2014-2015 Bilingual / ESL Education Annual Program Report Presenter: Tessie Young & Patricia Melgar-Cook

Patricia Melgar-Cook presented the 2014-2015 Bilingual / ESL Education Annual Program Report. Mrs. Melgar-Cook reported that Bastrop ISD is committed to ensuring the success of all English language learners through their participation in the bilingual and ESL programs.

B. Financial Report

Information was provided to the Board. Mrs. Callahan reported that the recent bond refunding saved the district more than \$12 million in interest savings totaling a savings of more than \$20 million in the past four years.

1. Budget Information

Sandra Callahan presented preliminary budget information for 2015-2016. Mrs. Callahan reported that although the legislature is halfway through, there is no information out yet however the House is expected to put out a plan tomorrow. She added that she should have a lot more information to bring in April.

Mrs. Callahan reviewed the 2015-2016 budget calendar and stated that the district would present a proposed budget to the board on May 19th and would ask the board to adopt the budget on June 16th. She stated that the tax rate would be adopted on September 15th. Ms. Callahan reviewed the proposed budget assumptions for 2015-2016 and reported that the budget is based on projected enrollment of 10,357 students and an average daily attendance at 9,421 for funding purposes.

A. Consider Approval of Certification of Unopposed Candidates for Board of Trustees Election Scheduled to be held on May 9, 2015

Barry Edwards presented a Certification of Unopposed Candidates for the Board of Trustees Election scheduled to be held on May 9, 2015. He reported that James Allen was the only candidate for Place 1 and Kellye Seekatz was the only candidate for Place 2. Mr. Edwards asked the board to approve the initiation of the cancellation process of the election by certifying that these two candidates are unopposed.

Ashley Mutschink moved and Matthew Mix seconded to approve the Certification of Unopposed Candidates for Board of Trustees Election scheduled to be held on May 9, 2015. President Allen asked for comments or questions. There being none, President Allen called for a vote.

B. Consider Approval of Order of Cancellation of Board of Trustees Election on May 9, 2015

Barry Edwards stated that James Allen (Place 1) and Kellye Seekatz (Place 2) have been certified as unopposed and are hereby elected as school trustees. Mr. Edwards asked the Board to adopt the Order of Cancellation and cancel the election scheduled to be held on May 9, 2015 in accordance with Section 2.053(a) of the Texas Election Code. Mr. Edwards stated that a preclearance letter would be sent to the Department of Justice notifying them of the cancellation of the election and Certificates of Election would be issued at the May board meeting. He added that the district is saving approximately \$14,000 by cancelling the election.

Matthew Mix moved and Ashley Mutschink seconded to approve the Order of Cancellation of Board of Trustees Election on May 9, 2015. President Allen asked for comments or questions. There being none, President Allen called for a vote.

C. Consider Cancelling Regular Board Meeting Scheduled for July 21, 2015

Superintendent Murray asked the Board to consider cancelling the regular board meeting scheduled for July 21, 2015 due to vacations and schedules. He reminded that the budget would already be approved.

Ashley Mutschink moved and Molly McClure seconded to cancel the regular school board meeting scheduled for July 21, 2015. President Allen asked for comments or questions. There being none, President Allen called for a vote.

D. Consider Approval of Interlocal Transfer Agreement with McDade ISD Sandra Callahan reported that several McDade ISD students attend Bastrop High School since there is no high school in McDade and asked the Board to approve an interlocal agreement with McDade in order for McDade ISD to pay tuition to Bastrop ISD.

Matthew Mix moved and Molly McClure seconded to approve the Interlocal Transfer Agreement with McDade ISD as presented. President Allen asked for comments or questions. There being none, President Allen called for a vote.

E. Consider Approval of Right of Entry to 194 Lots Held in Trust by Bastrop ISD in Tahitian Village and Pine Forest Unit 6 for Wildland Fuels Reduction Project

Bastrop County Office of Emergency Management Coordinator Mike Fisher reported that Bastrop County has been awarded a grant by FEMA to reduce wildland fuels loading in specific areas which were not included within the burn perimeter of the 2011 wildfires. Mr. Fisher asked the board to consider a Right of Entry to 194 lots held in trust by BISD in Tahitian Village and Pine Forest Unit 6 for the project. He added that Bastrop County would be purchasing up to five tractors and would like for the District to consider an agreement with the County which would provide a place to stage/park/maintain the equipment when not working on the projects.

Ashley Mutschink moved and Molly McClure seconded to approve the Right of Entry to 194 lots held in trust by Bastrop ISD in Tahitian Village and Pine Forest Unit 6 for Wildland Fuels Reduction Project and authorize the Board President to sign on behalf of the Board as presented. President Allen asked for comments or questions. There being none, President Allen called for a vote.
