President Allen praised his fellow board members and district administration for their efforts in trying to get the bond election and TRE passed in November. President Allen reported that the administration is working with architects and may change a few things this time around.

Mr. Murray reported that a short post-election survey is available on the districts' website through the holiday break. He stated that the district hopes to gain some valuable information from the survey results. Mr. Mutschink thanked the Bastrop Chamber of Commerce, the We Believe in BISD committee, and the Political Action Committee for all of their hard work leading up to the election. Mr. Moore stated that the district was proactive and looked at future projections and made the decision to call a bond election to re-tool the facilities that we have. He added that the items in the bond election are definitely needed, and the projects would be a great investment in the future. Mrs. McClure added that these elections are an opportunity to get out and talk about our schools and help people understand more about our schools.

### B. Resolution Concerning the A-F Accountability Rating System for Texas Public Schools

Superintendent Murray reported that in the Spring, the Texas Commissioner of Education will label each public school district and campus with a rating in the form of an A-F letter grade to comply with House Bill 2804. He added that many agree that there needs to be a better way to look at how schools are doing rather than relying on once a year standardized test scores. Mr. Murray stated that TASA has started a grassroots effort to pass a Resolution to repeal the A-F accountability rating system for Texas Public Schools.

Superintendent Murray read the Resolution and recommended the board approve the resolution as presented.

Billy Moore Moved and Ashley Mutschink seconded to approve the Resolution Concerning the A-F Accountability Rating System for Texas Public Schools as presented. President Allen asked for comments or questions. There being none, President Allen called for a vote.
